PROVIDER HOT SHEET

- ⇒ Quarterly Provider InfoShare Meeting: Plan to attend the next quarterly Provider InfoShare meeting to be held on Wednesday, August 29th, 2012 from 9:00 until 11:00 at Covenant Presbyterian Church, Fellowship Hall, 1000 E. Morehead Street, Charlotte. This meeting will be an opportunity to meet MeckLINK Behavioral Healthcare's new Director and to learn about Consumer Communications and Education.
 - Consumer Communications and Education: The Waiver Communications Committee is sending letters to all Medicaid Recipients in Mecklenburg County explaining that, as a Medicaid recipient, they are eligible for behavioral health services funded by Medicaid. This letter, along with an information sheet, will explain what the 1915 b/c Waiver is, the upcoming changes associated with the Waiver, what the changes will mean for them, and what they need to do if they currently have services or if they wish to receive services. The Information Sheet also includes a schedule for the public information sessions that will be held September through December. These sessions will be held at the Mecklenburg County DSS building on Billingsley Rd in the evening and are population specific. The December sessions will be in Spanish. All current CAP MR-DD recipients will receive an information sheet about the Innovations Waiver by mail. A Care-Coordination Information Sheet will be provided to all providers to give to consumers. All of this information will be available on the MeckLINK Behavioral Healthcare public website and contains contact information for MeckLINK for questions or assistance. Waiver Communication with Medicaid recipients will be ongoing and will include quarterly mail-outs, information sessions, focus group, forums, and other events.
- ⇒ A New Approach to Assessment: The Supports Intensity Scale (SIS) from the Developmental Disabilities Training Institute: Attention providers of services to consumers with I/DD; The Supports Intensity Scale (SIS) website from the Developmental Disabilities Training Institute is an excellent resource for both providers and families to learn about and gain a greater understanding of the Supports Intensity Scale. - ⇒ Provider Claims Denials for "Invalid Diagnosis Effective Date": Claims submitted to MeckLINK Behavioral Healthcare must include a diagnosis and a diagnosis code/pointer. The code/pointer identifies what diagnosis is assigned to the service rendered. If submitted incorrectly, the claim will be denied for "Invalid Diagnosis Effective Date". Instructions for submitting a diagnosis and its associated pointer/code has been posted to the Provider Resource Library on the Mecklenburg County Area Mental Health website under Document Type Manual Guide: <u>Submitting Diagnoses</u>
- ⇒ Innovations Waiver Technical Manual: The Innovations Waiver Technical Manual has been posted to the Provider Document Library under the Manual/Guide Document Type on the MeckLINK Behavioral Healthcare website. This is an important document for all Agencies that will be providing Innovations Services in the MeckLINK Behavioral Healthcare Provider Network. The Innovations Waiver Technical Manual is part of all provider Medicaid Waiver contracts. Please take the opportunity to download and review this document.
- ⇒ The Administration for Children and Families "Youth Guide On Psychotropic Meds": The Administration for Children and Families (ACF), in collaboration with other agencies including SAMHSA, has created a Youth Guide on Psychotropic Medications. The Guide can be downloaded from the following web address: Youth Guide On Psychotropic Meds
- ⇒ The <u>National Resource Center for Youth Development</u> website states, "This new guide -written specifically for youth in foster care with input from youth and professionals- looks at ways to handle powerful feelings and behaviors and make healthy choices. Understanding how psychotropic medication can help and what other options are available can be challenging. This guide can help you decide what's best. Making Healthy Choices includes useful information, questions to ask, worksheets, and tips on:
 - Recognizing you need help
 - Knowing your rights about your health and who can help you make decisions
 - Considering your options, including helpful approaches other than medication
 - Making decisions about how best to stay healthy
 - Maintaining treatment (taking medication safely and continuing or stopping treatment after leaving foster care)"

A Spanish version is being completed and should be posted by the early Fall.

- ⇒ PCP/ISP Format Update: MeckLINK Behavioral Healthcare has received multiple inquiries regarding the status of a suggested PCP format for treatment plans completed by a provider agency on behalf of an individual they are supporting. Please be aware that this is a subject being discussed at MeckLINK Behavioral Healthcare amongst the clinical team and the format is still under consideration. At this time providers should continue with business as usual, utilizing the state PCP format for treatment planning. Further direction and information will be shared via the Hot Sheet as it becomes available.
