

# MECKLENBURG COUNTY Area Mental Health, Developmental Disabilities and Substance Abuse Services August 27, 2012

#### **PROVIDER HOT SHEET**

- ⇒ Quarterly Provider InfoShare Meeting: Plan to attend the next quarterly Provider InfoShare meeting to be held on Wednesday, August 29th, 2012 from 9:00 until 11:00 at Covenant Presbyterian Church, Fellowship Hall, 1000 E. Morehead Street, Charlotte. This meeting will be an opportunity to meet MeckLINK Behavioral Healthcare's new Director and to learn about Consumer Communications and Education.
  - Consumer Communications and Education: The Waiver Communications Committee is sending letters to all Medicaid Recipients in Mecklenburg County explaining that, as a Medicaid recipient, they are eligible for behavioral health services funded by Medicaid. This letter, along with an information sheet, will explain what the 1915 b/c Waiver is, the upcoming changes associated with the Waiver, what the changes will mean for them, and what they need to do if they currently have services or if they wish to receive services. The Information Sheet also includes a schedule for the public information sessions that will be held September through December. These sessions will be held at the Mecklenburg County DSS building on Billingsley Rd in the evening and are population specific. The December sessions will be in Spanish. All current CAP MR-DD recipients will receive an information sheet about the Innovations Waiver by mail. A Care-Coordination Information Sheet will be provided to all providers to give to consumers. All of this information will be available on the MeckLINK Behavioral Healthcare public website and contains contact information for MeckLINK for questions or assistance. Waiver Communication with Medicaid recipients will be ongoing and will include quarterly mail-outs, information sessions, focus group, forums, and other events.
- ⇒ <u>Cultural Competence Plans</u> Thank you to the 61 agencies who responded to the Cultural Competence and Disaster Response Survey. 55 agencies reported having a written cultural competence plan. The Cultural Competence Plan Quality Improvement Project requires that you submit copies of your Cultural Competence Plan. Please mail, email or fax your Cultural Competence Plans to me by August 31, 2012. Thank you in advance.

- ⇒ Extension of Submission Date for the <u>Agency Application Process</u> for participation in the 1915(b)(c) waivers through MeckLINK Behavioral Healthcare: Due to September 30, 2012 falling on a Sunday, MeckLINK Behavioral Healthcare has extended the deadline for acceptance of Agency Applications to be included in the Standard Review process. Provider Applications received prior to 12:00 PM, October 1, 2012 will be part of the Standard Review process. Provider Applications received after 12:00 PM, October 1, 2012 will be processed in the order they are received. MeckLINK Behavioral Healthcare expects a large volume of provider applications and cannot guarantee applications received after 12:00 PM, October 1, 2012 will be processed prior to January 1, 2013.

- ⇒ Licensed Independent Practitioner (LIP), Group Practice, and Hospital & Inpatient Psychiatric Facility Applications and Processes for participation in the 1915(b)(c) waivers through MeckLINK Behavioral Healthcare: MeckLINK Behavioral Healthcare is working with the Credentials Verification Organization (CVO), Medversant, to finalize the "Web Portal" for the LIP, Group Practice, and Hospital & Inpatient Psychiatric Facility Applications. The "Web Portal" should be available the week of September 10, 2012. All forms and instructions for submitting a LIP, Group Practice, and Hospital & Inpatient Psychiatric Facility Application will be available through the "Web Portal". The deadline for LIPs, Group Practices, and Hospitals & Inpatient Psychiatric Facilities to submit their applications will be 12:00 PM, November 16, 2012. LIP, Group Practice, and Hospital & Inpatient Psychiatric Facility Applications submitted after 12:00 PM, November 16, 2012 will be addressed on a case-by-case basis and will not be quaranteed a contract with MeckLINK Behavioral Healthcare
- ⇒ The Administration for Children and Families "Youth Guide On Psychotropic Meds": The Administration for Children and Families (ACF), in collaboration with other agencies including SAMHSA, has created a Youth Guide on Psychotropic Medications. - ⇒ The National Resource Center for Youth Development website states, "This new guide -written specifically for youth in foster care with input from youth and professionals- looks at ways to handle powerful feelings and behaviors and make healthy choices. Understanding how psychotropic medication can help and what other options are available can be challenging. This guide can help you decide what's best. Making Healthy Choices includes useful information, questions to ask, worksheets, and tips on:
  - Recognizing you need help
  - Knowing your rights about your health and who can help you make decisions
  - Considering your options, including helpful approaches other than medication
  - Making decisions about how best to stay healthy
  - Maintaining treatment (taking medication safely and continuing or stopping treatment after leaving foster care)"
