# Background:

Action:

- In March 2010, City Council accepted a Federal Aviation Administration (FAA) grant in the amount of \$3,424,194 for the construction of an extension to Taxiway 'D'. The grant funds 75% of the eligible project cost.
- In the same action, Council approved a contract with Blythe Development Company for construction of the extension in the amount of \$4,578,925.50.

- The contract provided for the construction of a northern extension of Taxiway 'D', which included the relocation of a hangar currently leased to the Carolina's Historic Aviation Commission, and the relocation of a small portion of Minuteman Way.
- This change order will provide for additional grading and utility changes needed for the museum hangar.
- The additional scope is eligible for grant funding at the rate of 75% of the change order cost. The Airport will request this additional grant funding under the FAA's obligation to provide up to 15% over the grant amount for project overruns.

### **Contract Terms**

- This contract duration is 210 calendar days.
- The project was bid on a unit cost basis.

### 2. Airport Baggage Handling Design

Action: Approve a contract with United Engineering Group, Inc. in the amount of

\$130,020 for the engineering design services related to the in-line baggage

system.

### Background:

- Charlotte Douglas International Airport received a grant from the Department of Homeland Security in the amount of \$45,431,845 for an inline baggage conveyor system in the terminal. The grant funds 90% of the design and construction of the system.
- In April 2010, City Council approved a contract with BNP Associates in the amount of \$880,000 for the design of the actual conveyors.
- The system will require some building modifications to the baggage level of the terminal.
- This contact will provide Engineering design services through bidding phase for the mechanical, electrical, plumbing and fire protection systems related to the building modifications.
- The grant will cover 90% of all design fees if the project is not constructed.

### **Contract Terms**

This contract amount is a negotiated fee based on a scope of work

The contract duration is approximately 6 months.

McMahan: Will this improve the time it takes for passengers to get their luggage? You can sometimes wait up to 30 and 45 minutes in baggage claim. You mentioned before about the possibility of the Airport taking over security and baggage.

Orr: I think it is very possible that the Airport could do this, through a third party. We could handle the baggage for the airlines and operate the checkpoints. The reason there is such a delay with the baggage is because the bags are loaded onto the aircraft so that the transfer bags come off first. That's to prevent someone's luggage not making the connection, which costs the airline money. After the transfer bags come off, then the local bags come off.

**Remarks:** The purchase price was determined by two independent appraisals and was reviewed by a third appraiser. Each appraisal takes into consideration the specific quality and quantity of the land. The tax value is determined on a more generic basis and will be higher or lower for land/house with certain attributes. Property is acquired per Federal Guidelines 49 CFR Part 24 of the Uniform Acquisition and Relocation Act of 1970. Acquisition costs are eligible for Federal Aviation Administration reimbursement.

### 7. Status Reports

### 1. Flight Tracks

Jack Christine, Airport Planning & Development Manager, addressed the committee regarding flight tracks. Numerous visuals were shared with the committee to demonstrate the multiple flight tracks the airlines used before RNAV procedures were adopted by the FAA two years ago. RNAV is a computerguided departure system. Members also viewed a map that shows the changes in the flight tracks with RNAV procedures. These changes create a concentration of flight tracks over the same particular areas. The Airport is working on an alternative that would help mitigate some of the complaints received from the community due to the RNAV procedures. Currently, when an aircraft departs, RNAV has the plane climb and hold at 8,000 feet so that arriving aircraft can fly above that at 9,000 feet. This procedure is referred to as "tunneling out." This artificial hold in the aircraft at 8,000 feet is resulting in noise complaints. The Airport is working with US Airways and the FAA to try and amend some of these procedures and make some adjustments to the height of these aircraft. Currently, when aircraft are arriving to the Airport they are using a traditional step-down approach where they fly at a certain altitude for a little while, then drop down further and fly at that altitude. In terms of fuel, this is not cost effective. Optimized Profile Descent would allow the aircraft to do a standard descent with the engine idled. This would help conserve fuel and lower the noise. The Airport is working with the FAA to have arriving aircraft come in at 13,00 feet, as opposed to 9,000 feet. This would allow departures to do a continuous climb-out, which would in-turn, reduce the noise levels.

### 3. Paradies Take Over

Paradies, whose contract with the Airport was approved by City Council in September, will replace HMSHost as the Airport's retail provider and take over all existing leases by January 31, 2011. HMSHost will remain the Airport's Food & Beverage concessionaire. With Paradies as the Airport's new retail provider, the majority of CLT's existing retail venues will be reconcepted over the next year, with construction and renovations occurring in various phases. The first phase will include the following changes:

- Sunglass Designs (located in the Atrium) will become Taxco Sterling; Closing 1/31/11 and Reopening 2/4/11
- A Time to Write (located in the Atrium) will become Shades of Time; Closing 1/31/11 and Reopening 2/4/11
- NASCAR Shop (located in the Atrium) will become Brighton; Closing 2/28/11 and Reopening 5/20/11
- Daily News & Starbucks (located on Concourse B) will become Charlotte's Got A Lot News & Gifts; Closing 2/28/11 and Reopening 5/20/11

- Lids (located on Concourse B) will become Starbucks; Schedule TBD--space goes to HMSHost
- Yadkin Valley Wine (located on the D/E connector) will become Lacoste; Closing 2/28/11 and Reopening 5/20/11
- Forever Silver (located on the D/E connector) will become Blackberry; Closing 2/28/11 and Reopening 5/20/11
- Harley Davidson (located on the D/E connector) will become Erwin Pearl and PGA Tour Shop;
   Closing 2/28/11 and Reopening 5/20/11

# 4. Director's Report

### Wendy's Coming Soon

- Wendy's is coming to Concourse A. The famous burger fast food restaurant will replace the existing Kentucky Fried Chicken, located between gates A5 and A7.
- The new concept will feature Wendy's traditional branding with a contemporary feel and look in furnishings, while offering a breakfast menu, in addition to lunch and dinner.
- Construction is anticipated to be completed by the middle of December.

### Rotary Flight of Honor Held

- On November 9th, the Rotary District 7680, in partnership with US Airways, sponsored another "Rotary Flight of Honor" from CLT.
- The flights transport WWII veterans to Washington DC for the day to see the WWII Memorial.
- The flight, which carries approximately 100 veterans, departed from Concourse D at 8:00 a.m. and returned on the same day at 8:00 p.m.
- The Airport offers complimentary Curbside Valet parking to the veterans, a dedicated security checkpoint screening lane and refreshments provided by the USO.
- The Flight of Honor is a service project of the Rotary District 7680 which honors the lives, valor and courage of WWII veterans who live in mid-western North Carolina.
- The Rotary District 7680 includes 14 counties in central North Carolina. There are 52 Clubs in this District with over 3,000 Rotarians who provide their time and talent towards the Rotary International goal of "Service Above Self."
