
#### Title VI Policy

#### 1. Adoption of the Agenda

Mr. Pleasant asked if any changes to the agenda are necessary. Hearing none, the December agenda was adopted by acclamation.

#### 2. Consideration of Consent Agenda

Mr. Pleasant explained that the consent agenda for the December meeting contained the following three items:

- a. Approval of November 5, 2015 TCC Minutes
- b. Approval of TIP amendments for locally administered projects
- c. Approval of TCC Meeting Dates for 2016

#### Motion:

Jonathan Wells made a motion to adopt the consent agenda. Bill Coxe seconded the motion. The motion passed unanimously.

#### **TCC BUSINESS ITEMS**

#### 3a. Prioritization 4.0

Presenter: Neil Burke

#### Summary/Action Requested:

Mr. Burke provided information to the TCC via a Power Point presentation, the contents of which are incorporated into the minutes here. The presentation covered the following points:

- He explained that the requested action on was to endorse the P4.0 Subcommittee membership
  to review the local input points methodology and oversee the local input points allocation
  process.
- He then reviewed a P4.0 schedule for 2016. Mr. Burke explained that subcommittee will be
  tasked with the review the local input points methodology from P3.0 in December and January,
  and the determination of a public involvement strategy given that there are separate local input
  point allocation periods for the Regional Impact and Division Needs tiers.

Mr. Coxe stated that CRTPO's approach in P3.0 was to mimic NCDOT's process of giving priority to highway improvements. He explained that the TCC should consider the impact that a potential project may have on creating a sense of place and land use implications instead of merely resolving congestion.

#### Motion:

Mr. Coxe made a motion to endorse the P4.0 Subcommittee membership to review the local input points methodology and oversee the local input points allocation process. Mr. Lesch seconded the motion. The motion passed unanimously.

#### 3b. 2040 MTP Amendments/2016-2025 TIP Amendments

**Presenter**: Robert Cook

#### **Summary/Action Requested:**

Mr. Cook explained that the requested action was to begin a public involvement period for a series of TIP and 2040 MTP amendments, as well as for the air quality conformity determination. A memorandum describing the attached amendments can be viewed here.

He explained that the amendments listed below generally fall into three categories:

- Clean up items from the 2016-2025 TIP development process: U-5712 and U-5714;
- Technical analysis to evaluate the air quality impacts of three alternatives in order to make a decision about a preferred alternative: I-5507; and
- Schedule accelerations that will result in projects moving into the first four years of the TIP: U-5907, U-5908, U-5703 and R-211EC.

Mr. Cook stated that the MPO approved allowing the TCC to begin the public involvement period following a review of the project list at its November meeting. The public comment period will start on December 11 and end on January 14.

Mr. Coxe inquired about the need for three scenario alternatives for the I-485 (I-5507) project in the air quality conformity determination, and will the three scenarios allow HOT 3+ in the express lanes. Anna Gallup explained that the three scenarios will inform the location of direction connection express lane interchanges, and all scenarios consider HOT 3+ in the express lanes.

#### Motion:

Mr. Coxe made a motion recommend the start of a public comment period on the TIP and MTP amendments, as well as for the required air quality conformity determination. Lisa Stiwinter seconded the motion. The motion passed unanimously.

#### **TCC Information Reports**

#### 4a. 2045 Metropolitan Transportation Plan Update

Presenter: Robert Cook

#### Summary:

Mr. Cook provided information to the TCC via a Power Point presentation, the contents of which are incorporated into the minutes <a href="here.">here.</a> The presentation covered the following points:

- He explained that a staff-led Steering Committee has begun preparation of the 2045 MTP. The
  purpose of this Steering Committee is to provide general oversight of the plan development
  process.
- An Advisory Committee comprised of TCC members and other regional staff will provide guidance to the Steering Committee, TCC and MPO. This committee will review and comment on the key plan components.
- The socioeconomic data update process is underway, and Rock Hill-Fort Mill Area Transportation Study and Gaston-Cleveland-Lincoln MPO will participate in this effort as well.
- The RFQ process to retain consultants for general MTP development assistance and updates to the cost estimate software is underway with the goal of beginning key elements of the MTP in the first guarter of 2016.
- Mr. Cook explained that CRTPO has a March 2018 adoption target for the 2045 MTP.

Mr. Pleasant reminded the TCC that the MTP development process is where member jurisdictions have the greatest influence in the project development process. He explained that TCC members should regularly be communicating with their MPO counterparts throughout the MTP development process to ensure that their jurisdictions priorities are included.

#### 4b. CTP Work Group Update

Presenter: Robert Cook

#### Summary:

Mr. Cook provided information to the TCC via a Power Point presentation, the contents of which are incorporated into the minutes <u>here.</u> The presentation covered the following points:

- He explained that the Work Group and staff have been involved in the review of outreach materials for the upcoming public involvement period.
- Mr. Cook explained that the Work Group has assisted in the process of developing an online survey that will be distributed to the member jurisdictions in January to determine how the CTP/Thoroughfare Plan is reference in local zoning and subdivision ordinances.
- The Work Group has discussed a process to undertake future amendments to the CTP.

- Mr. Cook stated that the Work Group has recommended that the issue of right-of-way reservation should follow the CTP map adoption process.
- The effort to populate the CTP database should be complete by the end of January.

#### 4c. Ozone Standard Update

Presenter: Megan Green

#### Summary:

Ms. Green provided information to the TCC via a Power Point presentation, the contents of which are incorporated into the minutes <a href="here.">here.</a> The presentation covered the following points:

- She explained that the U.S. Environmental Protection Agency (EPA) announced the final Ozone Rule on October 1, 2015.
- The EPA has lowered the Ozone standard from 75 parts per billion (ppb) to 70 ppb.
- Mecklenburg County's compliance value for Ozone has fallen to 68 ppb.
- North Carolina Division of Air Quality (DAQ) will designate attainment areas in 2017 based upon 2014 through 2016 Ozone data.
- Ms. Green explained that if Mecklenburg County is designated as "non-attainment" for Ozone that it would be a "marginal" classification where the county would have until 2020 to meet the federal standard.

Andrew Grant inquired about CRTPO's status for the CMAQ program if the area is reclassified from 'non-attainment' to 'attainment'. Loretta Barren responded to explain that CRTPO would still be eligible for CMAQ funds because this determination is based upon the 2008 Ozone standard.

#### 4d. Focus Area Representative Terms of Office

Presenter: Neil Burke

#### **Summary**:

- Mr. Burke explained that the TCC bylaws specify that the focus area representatives have a term limit of one calendar year.
- The Focus Area Representatives for Bicycle, Greenway, Pedestrian, and Public Health were appointed to the TCC in April of 2014.
- He explained that the bylaws specify the beginning of the term in January and there is no time limit to the number of terms served.
- The Bicycle and Pedestrian Work Group will discuss this topic at their December 10 meeting.
- Mr. Burke explained that endorsements for the Bicycle, Greenway, Pedestrian, and Public Health representatives will be requested at the January 7 TCC meeting.

#### **OTHER REPORTS**

#### 5a. NCDOT Report

Stuart Basham from NCDOT-Division 10 provided an update on the following initiatives:

- Work has started on the Monroe Bypass project west of US 601.
- A project to enhance safety and operations at NC 16 and Mount Holly-Huntersville Road is almost complete.

- He explained that the new location portion of the N. Graham Street/Mallard Creek Road project (U-2507A) is complete, however; utility relocation is taking longer than anticipated. Construction on the remaining portion of this project will commence in the spring of 2016.
- A series of bridge replacements along N. Tryon Street are underway that are associated with the Blue Line Extension project.
- The I-485 & Oakdale Road interchange construction is in progress and on-track for an April 2017 completion.

Anil Panicker from NCDOT-Division 12 provided an update on the following initiatives:

- The I-40 and I-77 Interchange (I-3819B) project "final improvements" has been accelerated due to additional state revenue. Right-of-way and construction is expected to begin in 2018. Mr. Cook added that this will require TIP and MTP amendments and a regional air quality emissions analysis that will start early in 2016.
- Division 12 has recently initiated an effort to coordinate several TIP projects in program years 2015 through 2019 that cross I-77 in Iredell County in an effort to minimize mobility disruptions.

Mr. Panicker also announced that Reuben Chandler has announced his retirement from the position of Division Engineer for Division 12, effective December 31, 2015.

#### 5b. Bicycle and Pedestrian Work Group Report

Curtis Bridges stated that the Bicycle and Pedestrian Work Group will continue the process of reviewing the sixteen TAP project applications during their meeting this afternoon. He explained that the goal of the Work Group is to have a ranked project list for review at the January TCC meeting.

#### 5c. Upcoming Issues

Mr. Burke provided updates on the following upcoming issues:

- CRTPO will have its FHWA/FTA Certification Review on December 15-16.
- CRTPO Orientation is scheduled for January 13, 2016. This event is held every two years for new
  and existing MPO delegates and alternates. TCC members and the general public are invited as
  well.

Mr. Cook reminded TCC members to work with their jurisdiction's managers to name the MPO delegates for 2016. He also explained that they will need to file the required paperwork before being able to vote at upcoming MPO meetings in 2016.

Ms. Barren announced that the Fixing America's Surface Transportation (FAST) act was signed into law on December 4, 2015.
