## 1. Call to Order

MPO Chairwoman Sarah McAulay called the April 2014 CRTPO meeting to order at 6:05 PM.

## 2. Adoption of the Agenda

Chairwoman McAulay asked if there were items to be added to the agenda or changed. No additions or changes were suggested.

### Motion:

Dottie Nash made a motion to adopt the agenda as presented. Joe Pata seconded the motion. Upon being put to a vote, the motion to adopt the agenda was approved unanimously.

#### 3. Citizen Comment Period

No citizens addressed the board.

### 4. Ethics Awareness & Conflict of Interest Reminder

Mr. Cook read the ethics awareness and conflict of interest reminder to the MPO.

## 5. Approval of Minutes

## Summary:

Chairwoman McAulay noted a change that was necessary to the March 2014 meeting minutes on page 3, item #9-Eastfield Road Small Area Plan Thoroughfare Plan Amendments. The reference to May being the time the MPO would be asked to take action to amend the Plan should be changed to April. No other changes were recommended.

## Motion:

Vi Lyles made a motion to approve the March 2014 meeting minutes with the change noted above. Ms. Nash seconded the motion. Upon being put to a vote, the March 2014 minutes were unanimously approved.

## 6. 2040 Metropolitan Transportation Plan & Conformity Determination

## Presenter:

## Summary:

Mr. Cook provided information to the MPO via a Power Point presentation, the contents of which are incorporated into the minutes. He stated that the MPO was requested to take the following action:

- a. Find the 2040 Metropolitan Transportation Plan and the 2012-2018 Transportation Improvement Program in compliance with the Clean Air Act Amendments of 1990 and the Moving Ahead for Progress in the 21<sup>st</sup> Century (MAP-21) legislation; and
- b. Adopt the 2040 Metropolitan Transportation Plan.

Comments received during the comment period that ended on March 19 were discussed. He stated that it was the staff and TCC assessment that nothing in the comments warranted substantial changes to the MTP or conformity determination report, or a delay in making the conformity finding or MTP adoption. Efforts to comply with an FHWA directive to conduct an analysis of the benefits/burdens of MTP projects on environmental justice populations were reviewed. The presentation concluded by stating that the TCC unanimously recommended that the MPO take the above-stated actions.

## **Motion-Conformity Determination:**

Mayor Jill Swain made a motion to find that 2040 Metropolitan Transportation Plan and the 2012-2018 Transportation Improvement Program to be in compliance with the provisions of the Clean Air Act Amendments of 1990 and Moving Ahead for Progress in the 21<sup>st</sup> Century (MAP-21) act. Ms. Lyles seconded the motion. Upon being put to a vote, the motion passed unanimously.

## Motion-2040 MTP Adoption

Mayor Swain made a motion to adopt the 2040 Metropolitan Transportation Plan as presented. Joe Pata seconded the motion. Upon being put to a vote, the motion passed unanimously.

## 7. Eastfield Road Small Area Plan Thoroughfare Plan Amendments

## Presenter:

Bill Coxe, Town of Huntersville

## **Summary**:

Mr. Coxe presented information to the MPO via a Power Point presentation, the contents of which are incorporated into the minutes. He stated that the request was to amend the Thoroughfare Plan for the following projects:

- a. Everette Keith Road
- b. Verhoeff Drive Extension
- c. Hambright Road Extension

Brief descriptions of each project were provided. Mr. Coxe noted that the Town of Huntersville had approved the proposed alignments. None of the three projects is classified as an Interstate, US or NC highway, therefore, based upon the CRTPO Memorandum of Understanding, their locations are determined only with the consent of the municipality. It was stated that the TCC unanimously recommended that the MPO approve the Thoroughfare Plan amendments.

#### Motion:

Dumont Clarke made a motion to amend the Thoroughfare Plan to incorporate the three changes as presented. Ms. Nash seconded the motion. Upon being put to a vote, the motion passed unanimously.

## Motion:

Mayor Swain made a motion to approve the TIP amendments as presented. Ms. Nash seconded the motion. Upon being put to a vote, the motion passed unanimously.

## 9. Ardrey Kell Road Thoroughfare Plan Amendment

Presenter:

Steve Blakley, Kimley-Horn

#### Summary:

Mr. Blakley presented information to the MPO via a Power Point presentation, the contents of which are incorporated into the minutes. He provided an overview of the proposed change to the Ardrey Kell Road Extension alignment and explained why the change was needed. He concluded by stating that the TCC had unanimously recommended that the MPO amend the Thoroughfare Plan as presented. Lanny Openshaw questioned the road's status of a thoroughfare and stated that it was being shifted to appease a developer. Mayor Becker echoed Mr. Openshaw's comment. Vi Lyles stated that the Charlotte city council had looked closely at the proposal and that it was also reviewed by the Charlotte DOT.

## Motion:

Michael Johnson made a motion to amend the Thoroughfare Plan as presented. Mr. Pata seconded the motion. Upon being put to a vote, the motion passed with 48 votes in favor of the motion and three votes cast in opposition. The votes against the motion were cast by Marvin, Mineral Springs and Stallings.

### 10. Federal Transit Administration Funds Administration

Presenter:

David McDonald, CATS

#### Summary:

Mr. McDonald presented information to the MPO via a Power Point presentation, the contents of which are incorporated into the minutes. He stated that request was to name the Charlotte Area Transit System (CATS) as the designated recipient of Federal Transit Administration (FTA) Section 5307 and Section 5310 funds. An overview of both programs was provided. He explained that under MAP-21, the region's lead transit agency should be identified as the designated recipient of Section 5310 funds and that CATS is the current designated recipient for both programs. Mr. McDonald concluded by stating that the TCC unanimously recommended that the MPO take the requested action.

### Motion:

Mayor Daune Gardner made a motion to approve CATS as the designated recipient of both Section 5307 and Section 5310 funds. Gary Savoie seconded the motion. Upon being put to a vote, the motion passed unanimously.

## 11. CRAFT Memorandum of Agreement Updates

#### Summary:

Mr. Burke presented information to the MPO via a Power Point presentation, the contents of which are incorporated into the minutes. He provided background on the Charlotte Regional Alliance for Transportation (CRAFT), then reviewed the five specific proposed updates to the memorandum of understanding: a. delete reference to the Lake Norman RPO; b. update MOA to list new MPO names; c. add Catawba Regional Council as signatory to the MOA and as a member of the Executive Committee; d. delete reference to executive committee meeting three times a year; e. add Iredell and Lancaster County to the list of county planning departments in Section 5.

### Motion:

Mayor Frederick Becker made a motion to approve the changes to the CRAFT Memorandum of Understanding. Ms. Lyles seconded the motion. Upon being put to a vote, the motion passed unanimously.

## 12. Prioritization 3.0 Update

Presenter:

## Summary:

Mr. Burke presented information to the MPO via a Power Point presentation, the contents of which are incorporated into the minutes. The presentation's focus was on the recent release of a partial list of Prioritization 3.0 scores. He emphasized that the information was incomplete and was subject to change. The preliminary scores in the three categories (Statewide, Regional and Division) were reviewed. The "cascading" component of the Prioritization process was discussed. Cascading is the process by which Statewide projects can be scored at, and receive funding from, the Regional and Division categories. NCDOT's TIP Branch will determine projects eligible for cascading. Mr. Burke stated that the MPO-adopted local input points methodology states that local points should not be applied to Statewide category projects that cascade into the Division category. Mr. Johnson asked how the NCDOT Division's will arrive at its scores. Mr. Burke replied that the Division's are currently working on a consistent allocation method.

## 13. FY 2015 Unified Planning Work Program

## **Summary**:

Mr. Cook presented information to the MPO via a Power Point presentation, the contents of which are incorporated into the minutes. The presentation's purpose was to update the MPO on the UPWP's development in advance of the anticipated May adoption request. The UPWP Review Subcommittee's local projects

recommendations were reviewed. All were recommended for approval except the City of Charlotte's crash data geo-location and validation project. The FHWA determined that the project was ineligible due to it being an ongoing project that lacked planning area-wide benefit. Funding levels were reviewed, as were several key projects such as the NCDOT-sponsored ramp metering study and the regional freight study. A TIGER planning grant is being pursued; however the study will proceed even if the grant is not received.

## 14. Upcoming Agenda Items

## **Summary**:

Two future agenda items were discussed:

- a. A Thoroughfare Plan amendment for a project known as the Mt. Holly North Loop. The project is a proposed extension of Mt. Holly Road and is being considered for removal from the Thoroughfare Plan.
- b. The MPO will be asked to certify the transportation planning process at the May meeting.

Mr. Cook also stated that staff is beginning an assessment of locally-administered projects and is sponsoring a training session for local staff involved in the administration of local projects.

## **LOCAL PROJECTS**

Twelve of the 13 proposals submitted for consideration are being recommended for funding. The Crash Data Geo-coding & Validation proposal submitted by the Charlotte Department of Transportation (CDOT) was deemed ineligible by the FHWA due to it being an ongoing project that lacked planning area-wide benefit.

Local projects are listed at the end of the memorandum.

#### **OTHER ISSUES**

- 1. The draft UPWP programs \$52,500 in Task Code II, Traffic Accidents. The funds are FY 2014 funds to be carried over into FY 2015 from a UPWP amendment approved by the MPO in March 2014 to support CDOT's Crash Data Geo-coding & Validation project. This project was funded as a local project.
- 2. The UPWP Review Subcommittee recommends the following:
  - a. Begin a process to determine how the Crash Data Geo-coding & Validation proposal can be expanded to provide planning-area wide benefits.
  - b. After FY 2015, individual traffic count efforts should be consolidated into a single, CRTPO-supported traffic count program. Efforts to determine how to implement such a program should begin soon in order to be ready for FY 2016.
- 3. The regional freight study (Task Code IV-8, Freight Movement/Mobility Planning) is being submitted for consideration as a TIGER planning grant. The project is intended to proceed if TIGER funding is not received.
- 4. Initial work on the 2045 MTP is funded in Task Code IV-1, Community Goals & Objectives.
- 5. Work to develop performance measures as required by MAP-21 is programmed in Task Code IV-1, Community Goals & Objectives.
- 6. CRTPO's contribution to the NCDOT regional ramp metering study is programmed in the amount of \$153,000 in Task Code VI-10, Corridor Protection & Special Studies.

Adopt a resolution certifying CRTPO's compliance with all federal statutes, laws, regulations, etc. associated with the transportation planning process.

### TCC RECOMMENDATION

At its May 1, 2014 meeting, the TCC unanimously recommended that the MPO adopt the self-certification resolution.

## **ATTACHMENTS**

  pertinent to the self-certification process, with staff responses provided in green text; and

#### **BACKGROUND**

The Code of Federal Regulations (23 CFR 450.334) requires MPOs to annually certify to the FHWA and Federal Transit Administration (FTA) that the transportation planning process addresses all major issues facing the MPO and is being conducted in accordance with all applicable requirements of the following:

- Section 134 of Title 23, United States Code (USC), section 8 of the Federal Transit Act (49 USC app. 1607
- Section 174 and 176(c) and (d) of the Clean Air Act (42 USC 7504, 7506 (c) and (d)
- Title VI of the Civil Rights Act of 1964 and the Title VI assurance executed by North Carolina under 23 USC 324 and 29 USC 794
- Section 103(b) of the Intermodal Surface Transportation Efficiency Act (ISTEA) of 1991 regarding the involvement of disadvantaged business enterprises in the FHWA and FTA funding planning projects
- Provisions of the Americans with Disabilities Act (ADA) of 1990 and US Department of Transportation regulations "Transportation for Individuals with Disabilities" (49 CFR parts 27, 37 and 38)

## Charlotte Regional Transportation Planning Organization FY 2014 Self-Certification Checklist

23 CFR\* 450.334 requires MPOs to annually certify to the Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) that its planning process is addressing the major issues facing the urban area and is being conducted in accordance with all applicable requirements of various federal regulations, statutes, etc.

The following checklist assists staff as it conducts the self-certification process. Each question is followed by staff's response, and if necessary, additional explanation.

- 3. Does the MPO boundary encompass the existing urbanized area and the contiguous area expected to become urbanized within the 20-year forecast period? [23 U.S.C. 134 (c), 49 U.S.C. 5303 (d); 23 CFR 450.308 (a)]
  - Staff Response: An official boundary has been established by the CRTPO policy board. The CRTPO is currently working with neighboring MPOs to develop agreements that transfer planning responsibilities from CRTPO to the appropriate MPO for portions of the Charlotte urbanized area located within their planning areas.
- 4. Is there a currently adopted Unified Planning Work Program (UPWP)? 23 CFR 450.314
  - a. Is there an adopted prospectus?
  - b. Are tasks and products clearly outlined?
  - c. Is the UPWP consistent with the MTP?

- h. Does it conform to the State Implementation Plan (SIP) (if applicable)?
- i. Is it updated/reevaluated in a timely fashion (at least every 4 or 5 years)?

Staff Response: YES to all of the above.

- 6. Is there a valid TIP? 23 CFR 450.324, 326, 328, 330, 332
  - a. Is it consistent with the MTP?
  - b. Is it fiscally constrained?
  - c. Is it developed cooperatively with the state and local transit operators?
  - d. Is it updated at least every 4 years and adopted by the MPO and the Governor? **Staff Response: YES to all of the above.**

- CRTPO's project ranking methodology includes a component that assesses a project's impact on the natural environment.

## **Staff Response:**

CRTPO maintains a database that includes all pertinent federal, state and local agencies involved in the above-mentioned endeavors in its planning process. Not-for-profit organizations are also included in the database. The agencies and organizations receive all MPO agenda packets and other public meeting notifications (e.g., public comment period notifications).

Also, CRTPO conducted a Resource Agency Consultation process for the development of the 2040 MTP to ensure that all appropriate agencies were provided the opportunity to become involved in the MTP's preparation.

## **ACTION REQUESTED**

Approve the start of a comment period to obtain public input on a proposal to amend the 2012-2018 Transportation Improvement Program (TIP) and to make an air quality conformity determination for the following two projects:

## 1. U-2507AA: Baucom Road Extension, Mallard Creek Road to IBM Drive

This is a new collector road and multi-use path from Mallard Creek Road to IBM Drive. It was previously identified as the IBM Connector. Its purpose is to provide better access to the local street network, improve bicycle and pedestrian connectivity and relieve left turning movements at IBM Drive/W.T. Harris Blvd and at W.T. Harris Blvd and Mallard Creek Road.

## 2. R-2248G: I-485/Oakdale Road interchange

The proposed interchange is an original element of I-485. In 1999, the MPO conducted an analysis of all proposed I-485 interchanges, and decided to delay construction of the Oakdale Road interchange "until the interchange area is more developed . . ." \* In 2007, it was decided to pursue the interchange's construction and the project was added to MUMPO's Candidate Projects List.

### TCC RECOMMENDATION

At its May 1, 2014 meeting, the TCC unanimously recommended that the MPO approve the start of a comment period.

### **BACKGROUND**


In June 2013, NCDOT requested that the MPO amend its TIP to add both projects. It was determined that an air quality conformity determination would be needed in order for the amendments to occur. The TCC decided to not pursue a conformity process and instead, to fold the two projects into the upcoming 2040 MTP process. Both projects are included in the adopted 2040 MTP, for which a conformity determination was made by the MPO on April 16, 2014. However, advertising for the 2040 MTP did not explicitly address the need for TIP amendments for the two projects, thus TIP amendments and a conformity determination are needed.

## **CONFORMITY DETERMINATION**

A regional emissions analysis is not required, therefore only a conformity determination Short Form will be needed to complete the conformity process.
