$\textbf{1.} \quad \textbf{Thoroughfare Plan Amendment-Mt. Holly North Loop} \ \, (\textbf{Cook})$

Description:

The purpose of this discussion will be to determine the level of public involvement necessary to remove this project from the Thoroughfare Plan.

The Mt. Holly North Loop is a proposed extension of Mt. Holly Road in northwest Charlotte that includes a new crossing of the Catawba River into Gaston County. It is on CRTPO's Thoroughfare Plan and is proposed to be a part of the CTP. After crossing the river, it becomes a part of what is known as the Belmont-Mt. Holly Loop on the Gaston-Cleveland-Lincoln MPO's (GCLMPO) Comprehensive Transportation Plan.

This topic was first discussed at the December 4, 2013 Transportation Staff meeting. At that time, the GCLMPO staff discussed the City of Mt. Holly's opposition to the project and the MPO's intent to remove its portion of the project from its CTP. Local staff determined that, in light of the action proposed by the GCLMPO, there was no need to keep the project on the CRTPO Thoroughfare Plan.

SUBJECT: Review of Initial P3.0 Data for legacy projects

Dear Mr. Voelker:

The CRTPO has completed an initial review of the inputs and cost estimates from the 3/31/2014 release of the initial scores for legacy SPOT projects.

In a review of the project inputs, we noticed that the project descriptions for H090962-A and H090962-B are switched and do not properly match the project limits. This may have some impact on the cost estimates that were generated for these projects.

We used the cost estimates that were prepared from CRTPO's 2040 Metropolitan Transportation Plan, and we found several projects that had variations in cost the SPOT-generated cost estimates.

In our review of the cost estimate data, we found nine statewide tier, 19 regional tier, and 22 division tier projects that had at least a 10% variance between the SPOT and 2040 MTP cost estimates. Enclosed within this letter, please find three spreadsheets that highlight the projects with significant (+/- 10%) cost differences that we would like to make you aware of.
