MEETING CALLED TO ORDER at 8:45am

Welcome

Carol Hickey opened the meeting. Hickey recognized Todd Nuccio for his selection by the ABA Judicial Lawyer's Division to receive the 2014 Burnham "Hod" Greeley Award. The award is given to individuals and organizations for making a significant, positive impact on public understanding of the role of the judiciary as an organization.

February minutes were approved by consensus.

Announcements/Open Items

Magistrate Video Project

Tom Eberly advised that the Magistrate Video Project was moving forward. Client software has been installed at the Magistrate's office and at the Huntersville and Matthews police departments. Next steps include gathering stakeholders to establish operational policies and then expand the capability to other agencies.

WRRC/Reentry

Tom Eberly informed members the NC Department of Public Safety (DPS) wants to partner with Mecklenburg County to establish a transition program that will allow offenders who are within 90-180 days of release from state prison to serve their remaining time at the Work Release Center. During this period, the offenders will be provided "wrap-around" services to prepare them to successfully return to the community. Services will be provided by the Sheriff's Office and community service providers. Eberly noted the work release facility is well-equipped to support the program. The first challenge is to obtain legislative changes that will permit offenders to serve a portion of their sentences outside of a state prison. Mecklenburg is constructing a plan that will be submitted to DPS in the next 45 days. DPS will take the plan to legislators and seek the required changes. The program directly supports the Justice Reinvestment Initiative reentry strategy adopted by CJAG last year.

Moore Place

Tom Eberly presented the Supportive Housing handout, raising to member's attention the positive outcomes observed at Moore Place, an 85-unit housing unit that provides permanent housing and support services to Mecklenburg County's chronically homeless population. The handout presents three case studies as evidence of how the program can dramatically reduce costs associated with the arrest and incarceration of frequent offenders.

Defendant Risk Assessment

Dr. Marie VanNostrand presented an overview of the Public Safety Assessment- Court, a pretrial risk assessment tool to be adopted by Pretrial Services in May. Mecklenburg County has been selected as a

national pilot site by the Arnold Foundation to implement the instrument, which examines nine factors predictive of an individual's likelihood to commit a new crime, commit a violent crime, or fail to appear for court. The objective, research-based assessment provides an accurate measure of risk on the basis of the person's criminal history and current charges and is unique in that it does not require an in-person interview. VanNostrand discussed the supporting research; reviewed the risk factors and the types of pretrial failure to which they were most closely correlated; and detailed how the tool has been validated. She further discussed why pretrial risk assessments were critical to the criminal justice system. A general discussion followed the presentation. Next steps include VanNostrand meeting with stakeholders individually to discuss a decision-making framework and implementation. Tom Eberly noted the tool will be implemented first, then stakeholders will collectively decide how the risk assessments will be used.

Open Discussion

Tom Eberly advised CJS's early budget is due this week and the final due March 28. Sheriff Bailey asked funding for upgrading the video arraignment system be given priority.

The Honorable Judge Regan Miller advised a new policy is forthcoming that will effect law enforcement in regards to the transport of persons requiring mental health treatment. The policy will ensure that not all persons requiring treatment will be taken to CMC-Randolph, but also to Presbyterian. The hospitals are negotiating the policy now and it will presented once an agreement is reached.

Miller also recognized Mecklenburg County for providing funding to purchase equipment that will allow video hearings to be conducted in involuntary commitment cases.
