VII. Voices & Choices Presentation

Lisa Renstrom, representing Voices & Choices, said that V & C had been working since the 1998 Regional Environmental Summit to find regional solutions to regional issues. One Plan for the Region is a blueprint of the region's vision to retain our quality of life, e.g. preservation of out natural resources, collaborative, wise growth planning and getting the most out of our local economic opportunities. In support of this effort, local civic leaders across the Central Carolinas have been contacted concerning a Quality of Life Resolution in the local resolve to protect our quality of life.

She distributed three items to the member of the Commission. After discussion of the proposed "fill in the blank" generic resolution, Pat Owen suggested that the EPC approve the resolution in concept, with final approval being made after the final wording had been decided upon. William Pugh moved (seconded by Christy Kluesner) that:

The EPC recommend to the Board of Commissioners that they pass the resolution tailored to Mecklenburg County's actions in the past and those now being made to protect the environment of the region.

After further discussion it was decided that John Barry would forward to the EPC the revised wording of the resolution for comment, and that the EPC's comments would be considered in the final wording. With this having been said, the resolution passed unanimously.

VIII. BREATHE Update

Pat Owens said that the BREATHE committee is planning to meet twice per month with briefings from the State air quality planning staff, County Attorney Marvin Bethune and State Department of Transportation planning staff. He said that the plan was to meeting until January for information gathering, then after January, begin discussions of options. He said that the committee will consider input from the State as well as tap into what other cities have done.

IX. Direction of EPC

Steve Weber stated that he would not be at the next meeting because of legal commitments. He said that the EPC should possibly address a restatement of its charter in an effort to make the Commission more proactive and by doing so, would possibly save some staff resources.

Pat Owens said that it seemed to him that most of the other advisory boards also concerned themselves with economic issues in addition to environmental issues.

After further discussion, the Department was requested to email copies of the EPC's charter for review.
