He said they Committee would continue to meet and prepare for their presentation to the Board of County Commissioners.

IX. Workshop on LUESA Advisory Boards

In light of the reorganization centered around LUESA, the EPC thought it was necessary to discuss the EPC's direction and areas of responsibility in relation to other advisory boards associated with LUESA's programs. Although further discussion was to be held at the March meeting, the following list of options was proposed as an initial list for discussion.

- #1: No reorganization. All citizen advisory boards would remain as presently constituted.
- #2: Dissolve the EPC because most of it's functions overlap other boards (air quality permit appeals etc would still need to be addressed).
- #3: Reconfigure the EPC into an air quality advisory board. Other boards would remain as presently constituted.
- #4: Same as #3 except the chairs of various boards would meet quarterly or semi-annually. The chairs of each board could comprise a new environmental protection or environmental policy commission.
- #5: The EPC would remain much the same as presently configured. An independent air board would be created for air quality. The EPC would become the umbrella commission that coordinated the activities of the other boards.
