

## **New Development Services Technical Advisory Committee**



Development Services staff, comprised of several City departmental staff, has been working to enhance and better align our land development services.

In June 2013 we included in our newsletter information about one of these initiatives: "Establish a new stakeholder process" to improve collaboration between staff, the development community, and community representatives." As a first step, staff developed a draft charter that defines a new committee to improve collaboration between staff and the development community. This draft charter was presented to CDOT Director's Roundtable and Subdivision Steering Committee prior to disbanding them and establishing one new comprehensive committee. In the June issue we also asked our newsletter readers to review and provide input of the draft charter. The new Development Services Technical Advisory Committee (DSTAC) will serve as one comprehensive committee whose purpose is to provide a forum of discussion and feedback of technical issues regarding land development services.
