
2007 YRBS: Grade Level Distribution

2007 HIGHLIGHTS

The Youth Risk Behavior Survey (YRBS), produced by the Centers for Disease Control and conducted every two years, assesses health risk behaviors that contribute to some of the leading causes of morbidity and mortality in youth.

In 2007, the YRBS was administered for the first time in 23 public middle schools in Charlotte-Mecklenburg County. Among the 1,632 middle school students participating:

- 49.3% were female
- 50.7% were male
- 45.0% were Black, non Hispanic
- 34.7% were White, non Hispanic
- 13.3% were Hispanic/ Latino
- 7.1% were of Other Races



Quick Facts about the Report

The survey content of the Middle and High School YRBS are similar with the exception that questions used in the middle school survey are worded differently to reflect appropriate reading levels of students. Participants in the survey completed a self-administered, anonymous questionnaire. Local parental permission procedures were followed before survey administration.

- Weight Management and Nutrition

Highlights from the Data

Positive Results



- Nearly 68% of middle school students reported having at least one teacher or other adult in their school that they could talk to if they had a problem
- The majority of students reported attended physical education (PE) classes on one or more days in an average week when they are in school.
- 74% of students have been taught about abstaining from sexual activity.

Areas for Improvement

- 62% of students reported being in a physical fight in the past year.
- 53% of middle school students reported bullying/harassment as a problem in their school.
- Among students who rode a bicycle,
 69% reported never or rarely wearing a helmet.

Charlotte-Mecklenburg Middle School Students

The first local YRBS was administered in 2005 but only included Charlotte-Mecklenburg high school students. In the spring of 2007 the YRBS was administered to both middle and high school students. The results of the middle school survey show some encouraging findings, but also point to behavior practices among middle school youth that could result in serious health consequences.

Key findings from the 2007 local middle school survey are highlighted below. State and national data for the 2007 middle school survey are not currently available preventing a state-national comparison of local data.

Personal Safety

Among students who rode a bicycle, never or rarely wore a bicycle helmet	69%
Never or rarely wore a seat belt as a passenger in the past 30 days	11%
Rode with a driver in a car or other vehicle who had been drinking alcohol in the past 30 days	27%
Carried a weapon such as a gun, knife, club in the past 30 days	30%
Was in a physical fight in the past year	62%
Had property, such as their clothing, or books stolen or deliberately damaged on school property one or more times in the past 12 months	32%

Bullying and Harassment

Have been harassed or bullied on school property one or more times during the past 12 months	26%
Have been the victim of teasing or name calling because of their weight, size, or physical appearance during the past 30 days	35%
Agree or strongly agree that harassment and bullying by other students is a problem at their school	53%

Psychological Health

Felt so sad or hopeless almost every day for two weeks or more in a row that they stopped doing some usual activities in the past year	21%
Seriously thought about killing themselves	18%
Made a plan about how they would kill themselves	13%
