# **BUILDING-DEVELOPMENT COMMISSION Minutes of February 17, 2009 Meeting**

Jon Morris opened the Building-Development Commission (BDC) meeting at **3:02 p.m. on Tuesday, February 17, 2009** in Charlotte Conference Room located in the Hal Marshall Service Center, 700 North Tryon Street, Charlotte, North Carolina.

# 1. APPROVAL OF THE MINUTES

The motion by David Shultz (seconded by Charley Watts) to approve the December 2008 meeting minutes and the results of the January 2009 virtual meeting passed unanimously.

## 2. BDC MEMBER ISSUES AND COMMENTS

Barry Hanson asked if the Department's recently announced continuing education seminar would meet SPE requirements. Joe Weathers stated that he did not believe that this particular seminar was sponsored by the Department and staff agreed to verify this assertion.

Danny Phillips asked if the process of sealing crawl spaces required a permit in Mecklenburg County. It was agreed that Phil Edwards and Gene Morton would offer an opinion prior to the next meeting date.

No additional comments were offered.

# 3. PUBLIC ATTENDEE ISSUES AND COMMENTS

No comments were offered.

#### 4. 2008 COMMERCIAL REVISIONS AND A/E PASS RATE PROGRAM UPDATE

Mr. Bartl provided a detailed history of the Architect/Engineer's Pass Rate Program and how it will work. He stated that the seal holders will collect the "pass/fail" events and the Department will post them on a quarterly basis. Jon Morris noted that throughout the process, the Department has worked with the community to expand this and other programs. He stated that this monumental effort was done to preserve department resources and to provide assistance to the community. Mr. Bartl added that the grade collection tool would be in place on July 1, 2009 and the program is scheduled to be implemented on January 1, 2010.

# 5. CITY OF CHARLOTTE FIRE DEPARTMENT/RESIDENTIAL REVIEW PROCESS

Chief Rob Kinniburgh provided information on the "Wright Avenue" Project and other such areas throughout the City of Charlotte where providing protection services is an extreme challenge. He suggested that if the Charlotte Fire Department was a part of the residential review process, most of the situations could have been resolved during the plan review stage. Mr. Bartl suggested that a special meeting be held with members from the BDC, Home Builders' Association and the Charlotte Fire Department to address this issue and seek an amicable solution.

# 6. REPORT ON MECKLENBURG COUNTY STIMULUS PROJECT PRIORITIES

Geri Walton provided the BDC with a copy of Mecklenburg County's list of projects submitted for consideration to receive funding from the Federal Stimulus Program. She noted that the projects are indeed "shovel ready" per the Federal requirements and at this time; no priority exists. The BDC members received the report as information.

## 7. UTILITY TRANSFORMER DISCUSSION

There was a discussion on the Department's Policy regarding the location of utility transformers installed in Mecklenburg County. Several members from the Industry stated their specific concerns about the Department's Policy and the issue of liability in the event of a disaster. The following is the Department's strategy moving forward:

- a) Continue meeting with concerned industry members to listen to their perspective and note the related issues and problems
- b) Continue seeking clarity from NCDOI on statewide criteria for separation standards
- c) Continue to monitor information from State officials. The BCC will receive a proposal to study the issue in a standing committee, Ad Hoc Committee or something similar

# A-6. ONSCHEDULE & CTAC NUMBERS

## **Booking Lead Times**

- OnSchedule Projects: for reporting chart posted on line, in the final week of January 2009, showed
  - 1-2 hour projects; at 1 work day booking lead time, except 2 days for County Zoning
  - 3-4 hour projects; at 1-2 work days booking lead time, across the board
  - 5-8 hour projects; at 3-4 work days booking lead time, with Environmental Health at 2 work days
- CTAC-BEMPFp running 2 work days on plan review turn around time, across the board
- Express Review booking lead time was; 6 work days for small projects, 7 work days for large

# **B. UPDATE ON DEPARTMENT INITIATIVES**

#### B-1. CC/CO/TCO details and other Documents work

- **Project Permit Master Plan Details (PPMP)**: There are currently 19 master plan projects in the program and 4 preliminary master plan projects. All active projects are progressing without any known issues. Preliminary projects are still in the review stage.
- Expungement of Records Project: The first major project component, to expunge all trades and projects that meet the document retention schedule from the database, is complete. Through January 2009, this work included over 1.2 million documents. We now focus on creating the weekly process to automatically expunge documents that align with the documents retention schedule.
- Green Permit Rebate Program: We have 17 applications, which total \$148,043 in rebates. There is one completed project which is being processed for payment. Two projects have been removed from the program (due to customer concerns about the Dept using their pictures).

  - o Place notices with AIA and PENC
  - o Post on meckpermit.com under "what's new-coming soon"
  - Customer interaction electronic or manual handouts pointing out;
    - If they passed, emphasizing how the superior category works
    - If they fail, pointing out how average and poor category works

# Ideas (other than A/E Pass Rate Incentives) needing further work/development

- Development of  $2^{nd}$  review charges, on a phased in –review failure rate triggered basis.
- Final design of Priority (advanced interactive) Review, walk thru reincarnation and other "Superior Performer" benefits
- Conditional permitting development and pilots
- *Uniform RTAP policy*
