FINAL DISPOSAL

Foxhole Landfill - The County proposes to increase the maximum fee charge for open top and compactor vehicles. This proposal is being made to reduce the tons disposed at the Foxhole, which had increased significantly in FY04. The proposed increase will be presented to the BOCC at their September 8, 2004 meeting. The WMAB approved the recommendation to submit the proposed fee charge to the BOCC.

Foxhole Landfill Advisory Council Meeting * The Foxhole Landfill Advisory Council meeting was held on July 27, 2004. An update on the repermitting process was discussed. The Council had no concerns at this time. The Foxhole Greenway is complete and open. A grand opening will be held in September or October.

KEEP MECKLENBURG BEAUTIFUL COMMITTEE * The next official Keep Mecklenburg Beautiful Committee will meet on August 23, 2004. The media attention on the removal of political campaign signs was great. The same efforts will go toward the November campaign.

WASTE REDUCTION

Residential * The PLANT classes schedule is being set for fall registration. The Wipe Out Waste guidebook is currently being updated. The guide will be distributed to the Towns. Mecklenburg County will partner with the City of Charlotte in hosting a Latino recycling initiative at Sugaw Creek Park on September 25, 2004.

Commercial * The waste characterization and single stream analysis submittal process changed one day prior to the BOCC's approval. The County Manager can approve Professional Service contracts and will no longer require the BOCC's approval and, as such, the R.W. Beck contract was not submitted to the BOCC. The negotiations process will began with RW Beck as the selected consultant. The County's Business Recycling Education/Awareness Program received a NACIO

Award and the Commercial Source Separation Awareness Program received a SWANA Gold Award. The SWANA Gold Award will be presented to the County at the September SWANA Conference. SWANA is the Solid Waste Association of North America and County Solid Waste staff will be present at the September Conference.

OLD BUSINESS

Capital Reserve * At the August 10, 2004 meeting the BOCC approved the monies for the capital reserve account. The money is available for improvement projects.

NEW BUSINESS

Rezoning - The County explained the rezoning review process with the Planning Commission. In its review Solid Waste will propose the submission of a solid waste management plan by the applicant stating how waste will be handled from businesses. Also included will be required recycling of wood, metal and concrete waste. This will be presented in October to the Charlotte-Mecklenburg Planning Commission.

Environmental Policy Group - At the July 13, 2004 meeting the BOCC directed the Environmental Protection Coordinating Council to hold a public forum on October 21, 2004 from 6:00 pm to 9:00 pm. The forum will allow the public to comment on the environmental impacts of development in the County.
