#### ACTION REQUESTED

Endorse the project list attached to this memorandum. The TCC unanimously recommended at its August meeting that the MPO endorse the list.

#### **BACKGROUND**

- 1. The Technical Coordinating Committee (TCC) presented a recommended list of economic stimulus projects to the MPO at its July meeting.
- 2. The funds were available due to bids for economic stimulus projects coming in under estimate.
- 3. The MPO endorsed the list and added a rehabilitation project on Independence Point Parkway.
- 4. The Independence Point Parkway project was able to be added due to a decision by the Federal Highway Administration (FHWA) allowing the Board of Transportation (BOT) to amend the state Transportation Improvement Program (TIP) to include projects from MUMPO's March TIP amendment action for which the BOT failed to amend the state TIP earlier this year.
- 5. Based upon the FHWA's decision, the MPO instructed the TCC to:
  - a. Review the March TIP amendment list to determine if additional projects can be added to the state TIP; and
  - b. Analyze the list endorsed in July to determine if reprioritization is appropriate.

#### **PROCESS**

#### Request to Project Sponsors

The sponsors of potential economic stimulus projects included in MUMPO's TIP amendments (but not added to the state's TIP) were contacted on July 20 and asked to provide information that would help determine if their projects were eligible to be added to the state TIP.

#### July 29 Transportation Staff Meeting

Based upon information provided in response to the July 20 information request, it was determined that the following projects were eligible for addition to the TIP:

- 1. NC 51/Fullwood Lane intersection improvement
- 2. NC 51/Monroe Road intersection improvement
- 3. NC 24-27 rehab, Reed Mine Road to NC 51
- 4. NC 24 rehab, Mallard Creek Road to I-77
- 5. NC 73 rehab, Odell School Road to NC 115

#### August 5 Transportation Staff Meeting

The following determinations were made at this meeting:

- 1. A complete reprioritization of the list endorsed in July was not appropriate.
  - a. The five additional projects deemed eligible for inclusion in the state TIP at the July 29 meeting would be added to the bottom of the list.
- 2. Based upon advice from Mecklenburg County Park & Recreation Department staff, the following greenway projects were moved to the bottom of the list because they may not be shovel-ready:
  - a. Trade Street Greenway
  - b. Little Sugar Creek Greenway
  - c. Irwin Creek Greenway

#### August 6 TCC Meeting

The following determinations were made at this meeting:

- 1. Based upon advice from Town of Cornelius staff, the NC 115 sidewalks and bike lanes project was moved to the bottom of the list as #16 because it may not be shovel-ready.
- 2. Based upon a request from the Town of Cornelius staff, a project to improve the US 21/Catawba Avenue intersection was added to the list as #17. (This project was part of the original list of economic stimulus projects developed earlier this year.)

The Long-Range Transportation Plan (LRTP) is required to be financially-constrained, in that the LRTP cannot include projects that cannot be reasonably funded during the timeframe of the Plan. The MUMPO Board approved revenue assumptions based on existing revenues at their June meeting.

MUMPO was given direction by the MUMPO Board at their July meeting to develop highway project lists to be tested for air quality and congestion based on three funding levels. The levels were as follows: 1) No new revenue beyond what is already assumed for the timeframe of the Plan, 2) an additional 1/8 cent, starting in 2016, and 3) an additional 1/4 cent, starting in 2016.

Attached you will find two spreadsheets:

• Draft No New Revenue

This assumes no new revenue beyond what is assumed for the timeframe of the Plan.

• Changes to Project Lists Based on New Additional Revenues

This summary sheet provides information about the projects that advance due to a 1/8 cent revenue increase or a 1/4 cent revenue increase.

O Please note that in the project list assuming an additional 1/8 cent revenue that two projects actually move back. This is due to a higher ranked project (Index #3011 – Independence Boulevard from Krefeld Drive to Hayden Way) needing all of the new revenue generated by the 1/8 cent for the 2025 horizon year period, thus displacing the lower ranked projects to the 2035 horizon year period.
