TCC RECOMMENDATION: The Technical Coordinating Committee unanimously recommended that TCC members should continue to work closely with their MUMPO delegates to identify projects eligible for Division 10 NCDOT "small project" funding or STP-DA funding. Individual municipalities should contact NCDOT Division 10 staff to discuss candidate projects.

9. **Regional Transportation Planning Study** Rebecca Yarbrough ACTION REQUESTED: Provide comments on the study's recommendations.

BACKGROUND: The Centralina COG is scheduled to release its Regional Transportation Planning Study on November 15.

10. Waxhaw Parkway Alignment Study Update ACTION REQUESTED: FYI

BACKGROUND: MUMPO contracted with Kimley-Horn to perform an Alignment Study of the Waxhaw Parkway. The presentation will include both the analysis of the currently proposed alignment as well as some possible alternate alignments identified during the preliminary design portion of the Study. The Study is presently in the Final Design stage and is expected to be complete by the end of the year.

1. Call to Order

MPO Chairman Ted Biggers called the September 2010 MUMPO meeting to order at 7:10 PM. Chairman Biggers indicated that the agenda would be revised to move agenda item #7 (Charlotte Railroad Corridor Improvements) to the top of the agenda.

2. Charlotte Railroad Corridor Improvements

Presenters:

Michael Shumsky & Matthew Simmons, NCDOT-Rail Division

Summary:

Mr. Shumsky and Mr. Simmons presented information to the MPO via a Power Point presentation, the contents of which are incorporated into the minutes. The presentation covered the following points:

- North Carolina received over \$500 million in economic stimulus funds
- The funds will be devoted to track improvements between Charlotte and Raleigh
- Local projects include
 - Constructing a grade separation between the CSX and Norfolk Southern railroads in Charlotte's Fourth Ward neighborhood
 - Installing a second track between Junker (Mecklenburg County) and Haydock (Cabarrus County)
- The double track project will result in curve realignments, bridge improvements and the installation of new signal systems.

3. Approval of Minutes

Summary:

Chairman Biggers asked if everyone had an opportunity to review the July 2010 minutes and called for a motion.

Motion:

David Howard made a motion to approve the July 2010 minutes as presented. Sarah McAulay seconded the motion. The July 2010 minutes were approved unanimously.

4. Citizen Comment Period

<u>Summary</u>: There were no public comments.

5. Lake Norman Bike Plan

Presenter: Blair Israel, Centralina COG

Summary:

Mr. Israel stated that the Lake Norman bike plan had been presented to the MPO earlier in the year for an "endorsement," but NCDOT now wants the affected MPOs, RPOs and municipalities to "adopt" the plan. The request before the MPO was to adopt the plan and to authorize the MPO chairman to sign a memorandum of understanding (MOU) that set forth the commitments of participating agencies. Mr. Howard asked

if there were plans to ensure that the routes associated with the plan could be used as transportation routes. Mr. Israel replied that one of the plan's goals is to make bicycling a more feasible transportation mode. Mayor Anderson expressed doubt that residents will use bicycles for transportation. She also expressed concern about the project diverting funds from roadway projects.

Motion:

Mr. Howard made a motion to adopt the Lake Norman Bike Plan and to authorize the MPO chairman to sign the MOU. John Collett seconded the motion. Upon being put to a vote, the motion passed with one dissenting vote cast by the Town of Weddington.

6. FY 11 Unified Planning Work Program (UPWP) Amendment

Presenter:

Robert Cook

Summary:

Mr. Cook stated that the request was twofold: to reallocate \$56,624 in Planning (PL) funds and to change the description of the Town of Davidson's transportation planning project.

The reallocation was presented as follows:

1. Reallocate \$50,000 from Task Code VI-12, Management & Operations, to Task Code VI-10, Corridor Projection Studies. The towns of Matthews and Stallings will each receive \$25,000 to participate in a transportation plan with Indian Trail.

2. Reallocate \$6,624 from Task Code VI-12, Management & Operations, to Task Code III-3, Travel Model Updates. This will support overall travel demand model maintenance.

Regarding the change to Davidson's project, the Town had sought the funds to assist in the preparation of study of the NC 115/Potts-Sloan-Beary corridor. Due to the Town's Board of Commissioners not including matching funds in its FY 11 budget, the PL funds will be used to support the preparation of a downtown parking study.

Motion:

Ms. McAulay made a motion to amend the FY 11 UPWP as presented. Mr. Howard seconded the motion. Upon being put to a vote, the motion passed unanimously.

7. Monroe Parkway Project Status Update

Presenter:

Reid Simons, NCTA

Summary:

Ms. Simons presented information to the MPO via a Power Point presentation, the contents of which are incorporated into the minutes. The presentation covered the following points:

- Record of decision (ROD)-signed in August
- The right-of-way (ROW) process will begin soon-approximately 500 parcels will have ROW or easement claims
- Bond sales and overall financial schedule
- Toll operations, including location of toll zones
- Transponder program

8. Small Project Ranking

Presenter:

Lauren Blackburn, TCC Representative, Town of Davidson & Barry Moose, NCDOT Division 10 Engineer

Summary:

Chairman Biggers requested that Mr. Moose review the highlights of a presentation from the May 2010 meeting. Mr. Moose briefly reviewed his presentation, covering some of the funding sources he uses to fund small projects. Jim Bensman stated that he preferred removing a percentage of equity funds for use on small projects and asked if doing so would affect existing projects. Mr. Moose stated that there would be an impact, and that some projects might have to be delayed. Ms. McAulay recommended that the TCC continue to work on the project and that this topic should be added to the November agenda for a final decision.

The Charlotte Area Transit System has been aggressively applying for competitive national grants. These efforts have resulted in award of federal grant funds for several projects which will require a TIP amendment to receive the funding. The projects and the corresponding financial awards are described below:

- Maintenance and restoration of vehicle maintenance equipment at the Tryon Street and N. Davidson St. bus garages. Project grant amount: \$1,949,600.
- Development of asset management system to track the condition agency's fleet, facilities and equipment. Project grant amount: \$400,000.
- Solar panel purchase and installation (TIGGER II). Project grant amount: \$1,000,000.
- Purchase of paratransit replacement buses. Project grant amount: \$421,580.

The attached resolution amends the requisite TIP projects to enable the approval and programming of the individual grants.

At its November meeting, the Technical Coordinating Committee (TCC) unanimously recommended that the MPO amend the TIP.

Background MECKLENBURG

The draft TIP review process has resulted in the identification of several issues that need to be addressed by the Technical Coordinating Committee (TCC) and the MPO. Providing greater clarity on these matters will allow staff and the MPO and TCC leadership to negotiate the TIP's content.

PINEVILLE Guidance sought from the MPO at this meeting will not constitute final action on the TIP, it will merely provide staff with direction on how to proceed on the most significant matters. It is STALLINGS anticipated that the MPO will be asked to take more formal action at the January meeting.

Listed below are the key issues identified thus far in the TIP development process, along with recommendations from the TCC. WEDDINGTON

WESLEY CHAPEL

1. Issue: Proposed Project Delays

TCC Recommendation:

- 1. Pursue additional information on R-211EC and U-4024
- 2. Let other delays stand
 - a. I-4750 delays ROW acquisition only
 - b. I-3311 does not add capacity
 - c. U-209B is a brief delay

Note: Indian Trail and Stallings have proposed to redirect funding from the U-3809 and U-3825 projects to fund the widening of a portion of Old Monroe Road. Additional information on the proposal is needed. This affects TIP project U-4714 which funds a planning and environmental study on Old Monroe Road.

4. Issue: Rea Road Extension (U-3467)

Does the TCC support funding this project?

The TIP includes \$2 million in construction funds for the "A" section of the project which is a 1000 foot section of the project starting at NC 16. A developer was to construct the remaining portion of the road to NC 84, but the proposed development is defunct.

TCC Recommendation: More information is needed for this project.

5. Issue: STP Funding to CATS (U-5210)

Does the TCC support providing \$1.5 million in Surface Transportation Funds to CATS?

TCC Recommendation: Funding is supported due to it being directed to a capital project-replacement of the fuel farm at the N. Davidson St. garage.

6. Issue: Including Augustalee projects in the TIP

Does the TCC support including the five Augustalee projects in the TIP?

- I-5126 I-77 widening
- I-5127 Westmoreland Road interchange
- U-5128 Statesville Road widening
- U-5130 Jim Cooke Road, construct new road, Bailey Rd to Northcross Dr Ext
- U-5131 Northcross Dr, construct new road, Jim Cooke Rd (prop) to Eagle Ridge Way Drive

TCC Recommendation:

- 1. Keep the I-77 widening (I-5126) and interchange project (I-5127) in the TIP
- 2. Drop Statesville Road (U-5128), Jim Cooke Road (U-5130) and Northcross Drive (U-5131)-these projects are not regionally significant
- 3. U-5131 will be dropped but will remain in TIP as U-5108 (STP-DA project)

This was not unanimously supported by the TCC. When put to a vote, the motion passed with 10 yea votes and 8 nay votes.

7. Issue: STP-DA Projects

- 3. U-5108, Northcross Drive: previously discussed; Cornelius to build as an STP-DA project
- 4. U-5116, Little Rock Road relocation: City needs to resolve issues
