1. Call to Order

MPO Chairman Ted Biggers called the November 2010 MUMPO meeting to order at 7:05 PM.

2. Approval of Minutes

Summary:

Chairman Biggers asked if everyone had an opportunity to review the September 2010 minutes and called for a motion.

Motion:

Sarah McAulay made a motion to approve the September 2010 minutes as presented. James Taylor seconded the motion. The September 2010 minutes were approved unanimously.

3. Citizen Comment Period

Summary:

There were no public comments.

4. CATS TIP Amendment

Presenters:

David McDonald, CATS

Summary:

Mr. McDonald stated that the need for the amendments is related to the receipt of federal grants. The TIP must be amended in order for CATS to spend the funds. The projects awarded funding were:

- Maintenance and restoration of vehicle maintenance equipment at the Tryon Street and N. Davidson St. bus garages. Project grant amount: \$1,949,600.
- Development of asset management system to track the condition agency's fleet, facilities and equipment.
 Project grant amount: \$400,000.
- Solar panel purchase and installation (TIGER II). Project grant amount: \$1,000,000.
- Purchase of paratransit replacement buses. Project grant amount: \$421,580.

It was noted that the TCC had unanimously recommended approval of the amendment.

Motion:

John Ashcraft made a motion to approve the TIP amendment request as presented. Ms. McAulay seconded the motion. Upon being put to a vote, the motion passed unanimously.

5. FY 11 Unified Planning Work Program (UPWP) Amendment

Summary:

Mr. Cook stated that the reason for the amendment was that the USDOT had restored Planning (PL) funds that had previously been rescinded. The total amount of funding to be programmed was \$291,642 and the task codes to which the funding was proposed to be applied were as follows:

- Task code: V-4, Transportation Improvement Program \$30,000
- Task code: II-10, GIS Analysis & Mapping \$114,600

D. Issue: Rea Road Extension (U-3467)

Does the MPO support funding this project?

The TIP includes \$2 million in construction funds for the "A" section of the project which is a 1000 foot section of the project starting at NC 16. A developer was to construct the remaining portion of the road to NC 84, but the proposed development is defunct.

Action

Motion:

Mr. Ashcraft made a motion to continue to pursue implementation of this project. Mr. Bensman seconded the motion. Upon being put to a vote, the motion passed unanimously.

E. Issue: STP Funding to CATS (U-5210)

Does the MPO support providing \$1.5 million in Surface Transportation Funds to CATS?

Action

Motion:

Mr. Howard made a motion to support funding of this project. Ms. McAulay seconded the motion. Upon being put to a vote, the motion passed with one dissenting vote. The dissenting vote was cast by Mr. Bensman.

F. Issue: Including Augustalee projects in the TIP

Does the TCC support including the five Augustalee projects in the TIP?

Mr. Bensman made a motion to endorse the TCC's recommendation on this item. The TCC's recommendation was as follows:

- a. keep projects I-5126 (I-77 widening) and I-5127 (I-77/Westmoreland Road interchange) in the TIP as privately funded projects
- b. Drop projects U-5128 (Statesville Road widening), U-5129 (Westmoreland Road improvements), U-5130 (Jim Cooke Road construction) and U-5131 (Northcross Drive extension) because they are not regionally significant

The motion was seconded by Mr. Howard, and upon being put to a vote, passed unanimously.

G. Issue: I-77 managed lanes project

The issue addressed was support for a managed lane project on I-77 from Charlotte to northern Mecklenburg County.

Action

Motion:

Ms. McAulay made a motion to support establishing an I-77 managed lanes project in the TIP. Mr. Ashcraft seconded the motion. Upon being put to a vote, the motion passed unanimously.

H. Issue: Independence Boulevard

This issue focused on the fact that there are two significant projects about to get underway on the Independence Boulevard/US 74 corridor (U-209B, widening from Albemarle Road to Conference Drive, and the Monroe Parkway), but nothing funded for the approximately 7 mile gap between the two projects.

Action

Motion:

Mayor Taylor made a motion instructing staff to draft a letter for the MPO chairman's signature requesting that NCDOT explore any and all possibilities for improvements to Independence Boulevard between the U-209B and Monroe Parkway projects.

8. Small Project Ranking

Presenter:

Lauren Blackburn, TCC Representative, Town of Davidson

Summary:

Ms. Blackburn reported that the TCC had recommended that work on this project be stopped. Its recommendation was based upon an inability to define what constituted a "small project." Instead, the TCC recommended that MPO representatives continue the current practice of working with their TCC members and Division 10 staff to pursue funding for small projects.

Motion:

Mr. Ashcraft made a motion to terminate work on this project. Mr. Howard seconded the motion. Upon being put to a vote, the motion passed unanimously.

9. Regional Transportation Planning Study

Presenter:

Bill Duston, Centralina COG

Summary:

Mr. Duston presented information to the MPO via a Power Point presentation, the contents of which are incorporated into the minutes. The presentation's purpose was to present the findings of the Regional Transportation Planning Study. One recommendation was that a new regional transportation planning agency should be created that would serve as an umbrella organization responsible for projects of a regional scope. This new organization would be based upon a model used in the Tampa/St. Petersburg region (which also has multiple transportation planning bodies) but would not replace the existing MPOs and RPOs. Mr. Duston asked that MUMPO work with the COG on a "go-forward" model.

10. Waxhaw Parkway Alignment Study Update

Presenter:

Steve Blakley, Kimley-Horn

Summary:

MUMPO contracted with Kimley-Horn to analyze the feasibility of the Waxhaw Parkway as currently depicted on MUMPO's Thoroughfare Plan, and to examine alternatives in the event the current proposed alignment was found to be unfeasible. Mr. Blakley presented the study's preliminary findings.

11. Adjourn

The meeting adjourned at 9:25 PM.

BACKGROUND

The City of Charlotte has received a \$25 million grant from the Federal Transit Administration (FTA) that will permit construction of a 1.5 mile segment of a proposed streetcar line. The segment in question runs from the Charlotte Transportation Center to the intersection of Elizabeth Avenue and Hawthorne Lane. (The entire project runs from the Rosa Parks Transit Center (near the I-85/Beatties Ford Road interchange) to the former Eastland Mall.)

FUTURE REQUIRED ACTIONS

Receipt of the grant requires the following actions to permit the project to proceed:

- 1. Amend the 2035 Long Range Transportation Plan (LRTP) This action is required because the LRTP shows the entire project in the 2035 horizon year. The proposed amendment will place the 1.5 mile segment in the 2015 horizon year, with the balance of the project remaining in the LRTP in 2035.
- 2. Amend the 2009-2015 Transportation Improvement Program (TIP) This action is required because the current TIP does not show funding for the project.
- 3. Make conformity determinations on the amended LRTP and TIP This action is required because MPOs must make conformity determinations not only on newly adopted LRTPs and TIPs, but on amended versions of the same documents.

Final action on the above matters will be requested at the March MPO meeting.

ACTION REQUESTED

The MPO is requested to approve the release of the attached amendment report and draft conformity determination report for public review and comment.

At its January meeting, the Technical Coordinating Committee unanimously recommended that the MPO take the above requested action.

2035 LONG-RANGE TRANSPORATION PLAN AMENDMENT

INTRODUCTION

This report constitutes an Amendment to the 2035 Long-Range Transportation Plan (LRTP) for the Mecklenburg-Union Metropolitan Planning Organization (MUMPO). Based on this analysis, the 2035 LRTP for MUMPO remains consistent with the North Carolina State Transportation Improvement Program (STIP). The Fiscal Year (FY) 2009-2015 TIP is a subset of the 2035 LRTP. The LRTP has a 25year planning horizon. The original 2035 LRTP was adopted by MUMPO in March 2010, found to conform to the State Implementation Plan and approved by the Federal Highway and Federal Transit Administrations on May 3, 2010.

AMENDMENT DETAILS

Periodically it becomes necessary to amend the LRTP. In this instance, MUMPO is amending it in order to accommodate the receipt of a \$25 million Federal Transit Administration (FTA) grant by the City of Charlotte for its streetcar project. The grant will permit construction of an approximately 1.5 mile portion of the project, from the Charlotte Transportation Center to Hawthorne Lane adjacent to Presbyterian Hospital. The adopted LRTP includes the streetcar project in its 2035 horizon year; however, the receipt of the grant funds will permit the 1.5 mile portion of the streetcar to begin operation sooner. As a result MUMPO proposes to amend the LRTP to add a 1.5 mile streetcar starter project to the LRTP's 2015 horizon year. MUMPO is also required to amend its 2009-2015 Transportation Improvement Program (TIP) for this project.

A copy of the 2035 LRTP is available on-line at www.mumpo.org.

AMENDED PROJECT RECOMMENDATION

As noted above, this amendment includes a change in timing to a portion of the streetcar project. This results in the addition of a 1.5 mile streetcar starter project from the Charlotte Transportation Center to Hawthorne Lane in the 2015 horizon year. This change triggers the need to reevaluate the regional impacts of the project and its anticipated implementation. Table 1 provides a summary of the planned project implementation date.

In addition, a public hearing will be held on Wednesday, February 16, 2011 from 4:00 PM-6:00 PM in Room 270-271 (2nd floor) of the Charlotte-Mecklenburg Government Center, 600 E. Fourth St., Charlotte, NC 28202.

The MPO is tentatively scheduled to take final action on Wednesday, March 16, 2011.

BACKGROUND

The Unified Planning Work Program (UPWP) is the MPO's annual listing of planning priorities and work tasks for the fiscal year. The UPWP includes a description of planning work and resulting products, the agency responsible for the listed work, time frames for completing identified tasks, project costs and funding sources.

FUNDING LEVELS

As has been the case the last few years, work on the UPWP is beginning without knowing the full amount of funds that will be available to carry out the MPO's responsibilities. SAFETEA-LU has not been reauthorized and Congress has not acted on an extension of the bill beyond the end of 2010. Therefore, the UPWP's development will begin with an assumption that funding levels for FY 2012 will be the same as FY 2011.

MUMPO's three funding sources and their FY 2011 funding amounts are listed below:

Planning (PL) funds \$725,493
 STP-DA PL funds supplement \$800,000
 Section 5303 funds \$388,824

LOCAL PROJECTS

MUMPO directs some of its PL funds to support local transportation planning projects initiated by its member jurisdictions. A request for candidate projects was sent to TCC members on November 22, 2010; the submittal deadline was December 17, 2010. The following candidate projects were submitted:

1. City of Charlotte

Project: extend Mecklenburg County land use-transportation-emissions model into Union

County

PL funds requested: \$80,000

2. Town of Cornelius

Project: support of MPO activities

PL funds requested: \$1600

3. Town of Huntersville

Project: traffic count program; pedestrian planning project; connectivity study; I-77/NC 73

interchange study; MPO process staff support

PL funds requested: \$28,000

FY 2010 UPWP MPO Memo January 12, 2011

4. Union County (2 projects)

Project: Monroe Parkway corridor plan

PL funds requested: \$120,000

Project: US 74 corridor revitalization plan

PL funds requested: \$200,000

5. Joint project: Mecklenburg County, Charlotte, Cornelius, Davidson and Huntersville

Project: Redline trail study PL funds requested: \$28,000

The amount of funds requested totals \$457,600. Sub-allocating the entire amount would significantly impact the MPO's ability to perform its basic functions, therefore, some of the above projects may not be funded, or the requested amount will have to be scaled back.
