- **4. Grant Endorsement: Davidson Elem School Safe Routes to Schools** Robert Cook *ACTION REQUESTED: Endorse the Davidson Elementary School's Safe Routes to Schools* (SRTS) grant application.

BACKGROUND: Davidson Elementary School failed to obtain MUMPO's endorsement prior to the SRTS application deadline; however, NCDOT's SRTS coordinator has stated that it will be acceptable to provide the endorsement at this time.

At its February 2008 meeting, the Technical Coordinating Committee (TCC) unanimously recommended that the MPO endorse this project.

5. Draft 2009-2015 Transportation Improvement Program Andy Grzymski *ACTION REQUESTED: Endorse the TCC-recommended STP-DA* projects for inclusion in the 2009-2015 TIP.*

BACKGROUND: The draft TIP includes \$20 million in STP-DA funds (\$10 million each in FY 2014 and FY 2015) to be allocated by the MPO. Staff solicited the MPO's member jurisdictions for candidate projects and received almost \$60 million worth of requests. At the TCC's February meeting, a set of guidelines for project selection was endorsed. Using the guidelines, the total number of projects was reduced to just under the \$20 million threshold.

At its March 2008 meeting, the TCC unanimously recommended that the MPO endorse the attached project list.
