6. I-485 Designation

ACTION REQUESTED: Endorse adding I-485 from I-85 west of Charlotte to I-77 north of Charlotte to the Interstate System.

BACKGROUND: MPOs must officially endorse the addition of new segments to the Interstate System. The TCC unanimously recommended at its January meeting that the MPO endorse adding the portion of I-485 described above to the Interstate System.

7. Draft Public Involvement Plan Revision

ACTION REQUESTED: Release the draft Public Involvement Plan (PIP) for public review and comment.

BACKGROUND: The need for a revised PIP is due to the adoption of SAFETEA-LU and the revised metropolitan planning rules that followed. The requested action will result in staff beginning the required 45-day public comment period. Final action on the PIP is expected at the March meetings of the TCC and MPO. At its January meeting, the TCC unanimously recommended that the MPO release the draft PIP.

8. Draft 2011-2017 Candidate Project List

ACTION REQUESTED: Release the draft Candidate Projects List (CPL) for public review and comment.

a. TIP Amendment: C-4953

ACTION REQUESTED: Amend the TIP to change the project scope from establishing regional express service to establishing a transportation demand program.

BACKGROUND: C-4953 is a CMAQ project funded during the 2004 Call for Projects and is for the establishment of regional express service to Waxhaw. The TCC unanimously recommended at its January meeting that the MPO amend the TIP.

b. TIP Amendment: C-4965B

BACKGROUND: C-4965B is a CMAQ project funded during the 2004 Call for Projects and is for intersection improvements at NC 115 and Washam Potts Road.

c. Project Fast Tracking Endorsement: C-4955

BACKGROUND: C-4955 is a CMAQ project funded during the 2004 Call for Projects and is for the establishment of a center city Charlotte parking and way finding system. Fast tracking will permit funds to be expended in 2009 and will waive the required local match.

BACKGROUND: The USEPA has notified the North Carolina Department of Environment and Natural Resources that the State Implementation Plan (SIP) for demonstrating attainment of the 8-hour national ambient air quality standard for ozone in the Metrolina area will be disapproved unless the state requests a voluntary reclassification. Either disapproval or reclassification will have implications for industrial sources and transportation planning in the region.
