**3. Safe Routes to School Endorsements** (5 minutes)

ACTION REQUESTED: Recommend that the MPO endorse local proposals for grants from NCDOT's Safe Routes to Schools program (SRTS).

BACKGROUND: Application requirements for the SRTS program require MPO endorsement of the applications.

BACKGROUND: MPOs must officially endorse the addition of new segments to the Interstate System.

**5. Draft Public Involvement Plan Revision** (5 minutes)

ACTION REQUESTED: Request that the MPO release the draft Public Involvement Plan (PIP) for public review and comment.

BACKGROUND: The need for a revised PIP is due to the adoption of SAFETEA-LU and the revised metropolitan planning rules that followed. The requested action will result in staff beginning the required 45-day public comment period. Final action on the PIP is expected at the March meetings of the TCC and MPO.

**6. Draft 2011-2017 Candidate Project List** (10 minutes)

ACTION REQUESTED: Request that the MPO release the draft Candidate Projects List (CPL) for public review and comment.

BACKGROUND: The CPL is adopted at the beginning of the TIP development process and represents the funding priorities of the MPO. It has been the subject of significant review and discussion at three Transportation Staff meetings. Final action on the CPL is expected at the March meetings of the TCC and MPO.

#### 8. Congestion Mitigation & Air Quality (CMAQ) Issues

**a. TIP Amendment: C-4965B** (10 minutes)

BACKGROUND: C-4965B is a CMAQ project funded during the 2004 Call for Projects and is for intersection improvements at NC 115 and Washam Potts Road.

**c. Project Fast Tracking Endorsement C-4955** (5 minutes)

BACKGROUND: C-4955 is a CMAQ project funded during the 2004 Call for Projects and is for the establishment of a center city Charlotte parking and way finding system. Fast tracking will permit funds to be expended in 2009 and will waive the required local match.

Either disapproval or reclassification will have implications for industrial sources and transportation planning in the region.
