1. Barton Creek Greenway TIP Amendment (C-5537) (G. Cook) Description:

This item is on the April 5 TCC agenda for action to amend the TIP. The discussion will focus on how the project will be paid for.

The following is the background information from the TCC agenda: *Barton Creek Greenway is to be approximately* ¹/₂ *mile long, connecting existing Mallard Creek Greenway to JW Clay Blvd at University Place. This greenway, scheduled to receive CMAQ funding in 2015, has become the primary option for a greenway bypass for Mallard or Toby Creek greenways during NCDOT construction affecting N. Tryon Street, which would close those greenways for approximately one year. The intent is to have Barton Creek Greenway completed by spring of 2014.*

2. Charlotte Urbanized Area Expansion (R. Cook) Description:

The Charlotte urbanized area (UZA) expanded significantly and will result in a considerable increase in MUMPO's planning area. MPO and RPO staff members from throughout the region met via conference call March 30 to begin to identify significant issues. The attachment lists the issues identified thus far.
