## **Project Information & Description**

1. Describe the project for which funding is being sought. Clearly state the project's purpose and need.

One of the Focus Areas for the recently adopted "Town of Huntersville 2030 Community Plan" was for the Downtown. The vision for Downtown Huntersville states:

"In 2030 Huntersville's Downtown will be a thriving, mixed-use town center with a variety of housing types (single-family, townhomes, live-work, and apartments), retail establishments, restaurants, offices, civic and recreational uses. The historic character of Downtown Huntersville will be preserved and enhanced through the integration of new with existing development, reflecting the highest quality architecture, resulting in a revitalized Downtown that is uniquely Huntersville. The Downtown street grid will be characterized by a well-connected network accommodating all modes of transportation (vehicular, pedestrian and non-motorized), including bus public transit and trains. The streetscape and public spaces will include attractive lighting, street trees and well-designed signage providing a safe, pleasant experience for visitors and residents alike. Public events, outdoor markets and art displays will activate

the Downtown area, creating a true "destination" experience and focal point for the Town of Huntersville."

A central component of this vision is the creation of a multimodal transportation system for downtown. The proposed "Downtown Huntersville Multimodal Transportation Plan" will provide the policy and planning framework for this system and further serve as the foundation for future capital investments (infrastructure, streetscape and signage) required to build this system, which will, in turn, facilitate the revitalization of Downtown Huntersville. In addition to the goals imbedded in the vision statement, the Plan will deal with issues of solid waste collection and freight movement and delivery in and through downtown.

The proposed "Downtown Huntersville Multimodal Transportation Plan" is supportive of a number of the goals and objectives set forth in the 2035 LRTP, as noted below:

#### Goals:

- Providing a transportation system that provides the public with mobility choices, including walking, biking and transit options.

## Objectives:

- Promote a safe, efficient and diverse public transportation system that is accessible to various segments of the population.
- Develop a transportation system that integrates pedestrian and bicycle modes of transportation with motor vehicle transportation and encourages walking and bicycling.

## **Project Information & Description**

The Town would like to further its traffic count data. This was last done in 2009. More up to date information would allow the Town to better assess its transportation needs throughout the Town. The town would hire a Consultant from the region to perform this task, while Town staff would act as the project manager.

Gathering traffic count data on various streets throughout the Town can and will support several of the MUMPO's goals and objectives:

#### Goals

Safe and Efficient – By conducting traffic counts on streets throughout the Town, Town staff we be able to use Town transportation funds more efficiently in problem areas while improving safety along roadway segments that show a greater need.

Quality of life – By conducting traffic counts on streets throughout the Town, Town staff can conduct improvements on roadway segments that are in the most need. While adding new data to an ongoing data base traffic patterns can be tracked and improved over time.

### **Objectives**

Streets and Highways – By conducting traffic counts on streets throughout the Town,
Town staff can continue its ongoing data base of traffic counts
and patterns. This information allows staff to map an appropriate
level of service for streets throughout the Town.

Financial - By conducting traffic counts on streets throughout the Town, Town staff can make investment decisions in the most efficient manner with limited funds.

3. Can the project be completed by June 30, 2014? Provide a project time line, including anticipated start and end dates as well as key milestones.

Once approved the Town would hire a Consultant from the region. Town staff feels that traffic counts would be taken before the end of 2013 with a finale report presented to the Town in the spring of 2014.


## **Union County Staff Comments**


**B-5370** Replace bridge #444 on SR 1506 (Price Dairy Road) – This is a non-thoroughfare road located within the Town of Unionville. It currently has substandard lane widths of approximately 9'.


**B-5371** Replace bridge #71 on US 601 over Clear Creek – US 601 is designated as a boulevard that needs improvement on the draft CTP. The future cross section of 4 lanes with a median and bike lanes should be accommodated in the new bridge.

\*B-5374 Replace bridge 3448 on SR 2153 (Trinity Church Road) – This road is designated as a minor thoroughfare in the Union County CTP dated February, 2012. It is identified as needs improvement and calls for a 2 A cross section (12' wide lanes and wide paved shoulders posted at 55 mph). The bridge should accommodate this cross section.

\*Project is located in the RPO's planning area.











