## <u>Program Presentation -:</u> Catawba Lands Conservancy

<u>Chair Rob Brisley</u> **recognized** Director <u>Jim Garges</u>, who introduced Tom Okel, Executive Director for the Catawba Lands Conservancy a key Mecklenburg County Park and Recreation stewardship partner.

Catawba Lands Conservancy (CLC) is a land trust – a nonprofit, community-based conservation organization that permanently conserves and manages land for public benefit in the Southern Piedmont of North Carolina. Their six-county land protection area includes Catawba, Gaston, Iredell, Lincoln, Mecklenburg and Union counties.

CLC is also the lead agency for the **Carolina Thread Trail** (The Thread). The Thread is a 15county, two-state initiative designed to inspire and facilitate the creation and development of a regional network of trails, blueways and conservation corridors that will link more than 2.3 million citizens. Today, 92 miles of The Thread are open to the public.

In Mecklenburg County, the Carolina Thread Trail incorporates

- Clark's Creek and Mallard Creek Saxonbury to Countryside School
- Clark's Creek and Mallard Creek Saxonbury to Fairlea
- Clark's Creek and Mallard Creek University Research Park to Kirk Farm

- Little Sugar Creek Cordelia to Alexander
- Little Sugar Creek Freedom Park
- Little Sugar Creek Morehead to Brandywine
- Little Sugar Creek Huntingtowne Park
- McDowell Creek
- Southeast Creek
- Torrence Creek

#### **Director's Report**

(a) Whittington Field Public Hearing, August 20, 2012 – Update and Outcomes

Director Jim Garges reported to the Park and Recreation Commission, that with the approval of the County Manager, Mecklenburg County Park and Recreation – Park Operations, and the Central Advisory Council, the request of the Dilworth Little League for modification of the Whittington Field has been approved.

<u>Commissioner Charlie McRee</u> (Central Region - C3) provided a summation of the events leading up to the Public Hearing:

Roughly a year or so ago Dilworth Little League approached Park and Recreation about expanding the **Jim Whittington Little Field** on Princeton Ave. to comply with new **Little League** field required dimensions. Little League players, like all youth today, are bigger and stronger than years ago and from a safety standpoint it was felt that the pitcher was too close to the batter and a line drive could be on him before he can react. The same could be said about the infielders. It was decided to enlarge the field and move everyone back a few feet. (To be sanctioned by Little League and qualify for tournaments your field has to be the new dimensions, which will be required of all Little League fields in the USA) This would not be a big deal where there is room for expansion, except with Whittington field, it would require removing 21 trees and bumping up next to the sidewalk on Princeton.

Whittington Field was built in 1953 which makes it the oldest or certainly one of the oldest Little League fields in Mecklenburg County. The bleachers and concession stand with restrooms are built of brick which cannot be said about any other field. There is a lot of feeling (emotions) as generations have played and coached there and it is considered to be a special place to play for the older players.

Their first proposal was rejected by Park and Recreation, but after some back and forth discussion Dilworth submitted a plan that is acceptable. Dilworth LL will pay all cost and any trees removed will be replaced with new trees and everything will be under the supervision of Park & Rec.

We had a public forum which was attended by about 25 people and there were no objections. I personally met with several neighbors and also spoke with several coaches and everyone was OK with the expansion. There is always a little heartburn when trees are cut down but of the 21 trees only 2 were hardwoods and one of those has to be pretty radically trimmed as the limbs come on to the current field. The county arborist will be involved in the planting of the replacement trees which will probably make it more attractive in the long run.

The right field will not be expanded to the full distance of 205 feet required because of the sidewalk next to Princeton, but Dilworth has been given an exemption and there will be room to plant a tree and there should not be any safety concerns for pedestrians walking on the sidewalk. (new distance will be 195ft.)
